# 2 - Moved by Webster, Seconded by Hannon that WHEREAS the public electricity system in Ontario is a critical asset to the economy and vital to the living standard and well-being of all Ontarians; AND WHEREAS it is essential that Ontarians maintain public control and public decision-making with respect to electricity; AND WHEREAS experience in other jurisdictions shows that privatization typically means consumers pay more for electricity; AND WHEREAS a privatized Hydro One will no longer be subject to scrutiny by the Auditor General, the Ombudsman, the Financial Accountability Officer, or the Integrity Commissioner, and will no longer be required to provide information or services to citizens under the Freedom of Information and Protection of Privacy Act, the Public Sector Salary Disclosure Act, or the French Language Services Act; AND WHEREAS our public electricity system currently generates hundreds of millions of dollars in revenue for the provincial government every year to help pay for public services we all depend on; AND WHEREAS the sale of shares in Hydro One will provide a short-term financial gain for the province in exchange for a much larger long-term financial loss; AND WHEREAS the provincial government has no mandate from voters to sell any part of Hydro One; AND WHEREAS opinion polls show Ontarians oppose the privatization of Hydro One by a significant margin in every part of the province; THEREFORE BE IT RESOLVED that the Township of Melancthon call on the provincial government to:

Halt the sale of any part of Hydro One, and maintain Hydro One as a public asset for the benefit of all Ontarians;

Strengthen Hydro One by investing in the next generation of workers and upgrading our electricity transmission infrastructure;

Respect the autonomy and local decision-making powers of local distribution companies by not forcing these companies into mergers or sales;

AND BE IT FURTHER RESOLVED that the Township of Melancthon communicate this resolution to the Premier, with copies to the Minister of Finance, the Minister of Energy, area MPPs, and the Association of Municipalities of Ontario (AMO); AND BE IT FURTHER RESOLVED that the Township of Melancthon work through AMO to encourage other Ontario municipalities to express their opposition to the privatization of Hydro One. Carried.

Discussion ensued. The by-law requires some tweaking and should have some times when these vehicles are restricted on the Township roads but we also need to take into consideration the needs of farmers and hunters. There are two areas we are dealing with and that is the Aggregate issue – extraction below the water table and Schedule G regarding vulnerable aquifers. Mr. Jorden updated Council on the issue before the OMB in the Region of Waterloo regarding extraction below the water table, and a settlement was reached. Three out of five of the matters have been resolved but two matters regarding extraction below the water table are being deferred. Mr. Jorden advised Council of the approaches he is seeking to take with the OMB on both of these issues and is hopeful that the hearing on August 19<sup>th</sup> will be more of a mediation session.

A date and time of Thursday, October 15, 2015 at 4:00 p.m. was set to discuss the above noted matters in Committee of the Whole.

#### **Unfinished Business**

<u>Letter from G.W. Jorden, Planning Consultants Limited dated June 8, 2015, Re - The Meaning of the Term "Agricultural Storage Building" as Used in the Building Permit Application by Mr. Jeff Holmes</u>

Mr. Jorden was still in attendance for this portion of business. It was advised that Mr. Holmes did come into the office and pay the development charges. Discussion ensued and it was suggested that we should look at the wording of the Development Charges By-law, particularly the word "ancillary" use. The CAO/Clerk was asked to bring this matter forward in the Fall at the October meeting.

Report to Council from Jerry Jorden, Planning Consultant dated June 12, 2015, Re-Proposed Residential Use Zoning Restrictions on Lands in: A. Part Lot 25, Conc. 3 O.S., -B7/14, B. Part Lots 17, 18, & 19, Conc. 2, O.S. -B8/14, C. Part Lots 16-20, 21, Conc. 3, O.S. B10/14

Mr. Jorden was also in attendance for this portion of business and advised, in his opinion, that the proposed zoning by-law amendments as prepared for the Public Meeting held on May 21, 2015 have no adverse effects on the lands. He explained that if Bonnefield decides to sell any of the residential lots, they would have to go through a consent application to separate them because all of the parcels were consolidated at the time they were purchased by Bonnefield. When this is done, a house would be permitted on those lots. The same would apply be for the larger farm parcels. During the consent process, there would be a condition made that would require the parcel to be rezoned to allow a dwelling. He advised that he can revise the By-law, however this would require research on where exactly the lots are and a recirculation. As Council concurred with Mr. Jorden regarding the no adverse effect on the lands, the following motions were passed:

B8/14 - Moved by Elliott, Seconded by Webster that leave be given to introduce a By-law to amend By-law No. 12-1979 as amended for lands located in Lot 25, Concession 3 OS and it be hereby read a first and second time. (Bonnefield). Carried. By-law numbered 32-2015 and read a first and second time.

B10/14 - Moved by Hannon, Seconded by Besley that leave be given to introduce a By-law to amend By-law No. 12-1979 as amended for lands located in Parts of Lots 16, 17, 18, 19, 20 and 21, Concession 3 OS and it be hereby read a first and second time. (Bonnefield). Carried. By-law numbered 33-2015 and read a first and second time.

Discussion ensued and again it was suggested that the wording of the Development Charges By-law pertaining to "ancillary" use be looked at. The mover and seconder agreed to withdraw the motion.

Mayor White advised that Melancthon is not really impacted by this study. There is a bridge in Corbetton that is proposed to be downloaded to us but it should really be our bridge because it is on our road and there are two bridges on Townlines – one on the Southgate/Melancthon Townline and one on the Mulmur/Melancthon Townline and these will likely remain with the County. There are no roads proposed to be downloaded to Melancthon. Council was asked to review the report and provide comments for the next meeting as the deadline for comments is July 31, 2015. The CAO/Clerk will scan and send out the Report. Council did not support Amaranth's motion as they didn't have any issues with the July 31st deadline.

Discussion ensued about the positive steps that have been taken moving forward - i.e. stop signs in Horning's Mills. This will be revisited in six months time. Craig was asked to look in to how much it will cost to have white lines painted in front of the new stop signs. Suggestions of creating a facebook page to get information out to the Public. The CAO/Clerk reported that Staff are working on a new website and that this could perhaps be incorporated into it. It was noted that we have to stay on the OPP so that they remain visual in the Hamlets.

Councillor Besley gave his verbal report of the Melancthon Township Police Services Board Meeting held on June 11, 2015.

### **Corbetton Park**

Moved by Hannon, Seconded by Besley that the Mayor and Clerk be directed to enter into the Memorandum of Understanding between the Corporation of the County of Dufferin and the Corporation of the Township of Melancthon regarding the County-owned former rail line lands located in the Hamlet of Corbetton. Carried. Mayor White advised that the County was giving Melancthon a \$10,000.00 grant for the Park. When proposing his motion at County, he linked it to the Transportation Trails Master plan. He indicated that he, the Road Superintendent and CAO would do a walk about to see what was required for the Park.

### **By-law Enforcement**

### <u>Shelburne Public Library - Children's Library Renovation</u>

Councillor Besley, who is the Shelburne Public Library Representative advised that Amaranth and Mono had sent their cheques in for the Children's Renovation. It was advised that the Library would not be doing a renovation again in an Election year as it

does not appear that the information was brought forth and past members are no longer on Council. Moved by Besley, Seconded by Webster that the Municipality of the Township of Melancthon forward the municipalities share for funding of the Children's Library Expansion at the Shelburne Public Library which was completed in 2014 in the amount of \$7,920.00. Carried.

8:10 p.m. - Council took a 10 minute break and reconvened at 8:20 p.m.

### **Additions**

Bruce Beach Preppers Event - it was brought to the Township's attention that an event would be taking place at the Bruce Beach property on Mill Lane on July 10-12, 2015. The website indicates that there will be tours of the underground bunker shelter. This shelter had an order against it to have the entrance welded shut. Councillor Webster advised that a similar event took place last year at the Horning's Mills Hall only it was referred to as a Convention. The CAO/Clerk was directed to contact the Township's Solicitor and have him send Mr. Beach a letter that the Township would be pursuing the Order to have the Bunker permanently closed and that we would also be taking steps to stop the event due to no permits being approved for it.

<u>Hill Machinery</u> - the CAO/Clerk advised that she had received a call from Jim Hill who is requesting a month's extension to have the property cleaned up. The company that is to be coming in to take out the large stuff has not come in yet as they are busy. The CAO/Clerk to find out who this company is and give them a call. Council did grant a one month extension to Mr. Hill.

#### <u>Other</u>

Councillor Besley inquired about the following:

<u>Hunt Trucking</u> - the CAO/Clerk advised that she has heard nothing further on the draft road agreement for half loads.

<u>Rogers Telecommunications Tower</u> - the CAO/Clerk advised that there will be a Public Information Session on July 8<sup>th</sup> at the Horning's Mills Hall. There is some information that will be in the next agenda package but the CAO will send out the information tomorrow to Council.

<u>GRCA Rep coming to Council</u> - the CAO/Clerk was directed to contact Guy Guardhouse and ask him to attend one of our Council meetings in the Fall for an update on GRCA issues.

At this time, Mayor White updated Council on a meeting he had with Eli Sherk, et al on Monday, June 15<sup>th</sup> regarding non-compliance of By-laws, as well as the Electors List for the 2018 Election.
