CORPORATION OF THE TOWNSHIP OF MELANCTHON

The Council of the Corporation of the Township of Melancthon held a meeting on the 6th day of April, 2017 at 5:00 p.m. in the Council Chambers. Mayor D. White, Deputy Mayor J. Elliott, Councillor D. Besley, Councillor W. Hannon and Councillor J. Webster were present. Denise Holmes, CAO/Clerk was also present. Mayor White presided and called the meeting to order.

Announcements

Mayor White advised that he has been offered the opportunity to meet with Premier Kathleen Wynne tomorrow morning for a few minutes. He hopes that those few minutes will enable him to invite her to have a longer meeting with him in the future.

Approval of Agenda

Moved by Hannon, Seconded by Besley that the agenda be approved as amended. Carried.

Disclosure of Pecuniary Interest and the General Nature Thereof

Mayor White advised that disclosure of pecuniary interest can be declared at this time or anytime throughout the meeting.

Minutes

Moved by Elliott, Seconded by Webster that the minutes of the March 16, 2017 Council meeting be adopted as circulated. Carried.

Planning Matters

Applications to Permit

Mayor White signed an application to permit a potato storage addition on the East Part of Lot 22 & 23, Concession 2 OS - A. Vander Zaag.

An application for a house addition on Part of Lot 221-222, Concession 2 N.E., Part Lot 222, Concession 1 NE was presented for Aaron Martin/Simon Martin. It was advised that the drawings suggest that it is a 2-unit dwelling and therefore a Zoning By-law Amendment would be required before approval of the application could be given. The CAO will advise the applicant of this.

The application for Allan and Joanne Nicholson for an indoor pool on Lot 20, Plan 7M48 was deferred as the Planner would like to check for lot coverage conformity.

Addition - Tupling Zoning By-law Amendment

Mayor White asked that this be added to the Agenda as there is a public meeting coming up at the next meeting for a Zoning By-law Amendment (ZBA) for Tupling Farms. Mayor White asked Chris Jones, Planning Consultant to explain the reasoning behind the ZBA. Mr. Jones advised that he met with Bert Tupling and his son shortly after the fire and said that the main part of the building consisting of the packing plant, office and equipment storage was destroyed by the fire. Mr. Jones advised that because they will be expanding what was destroyed by the fire from 40,000 square feet to 80,000 square feet he recommended that they go through a ZBA to grant them an exemption from the Township's On Farm By-law regulations related to on-farm business uses to allow the owners to rebuild the facility. He explained Section 4.6 b) x to the By-law which reads "the following uses may be permitted as on-farm business uses that are secondary uses to agriculture...support services that facilitate the production, marketing and distribution of agricultural products" and feels that the business falls under this section of the By-law. Had Mr. Tupling just replaced what was lost and not expanded, it could be approved as legal non-conforming because the business was in place prior to the 2012 when the On Farm Business By-law was passed.

It was asked if this would delay the progress of rebuilding and Council was advised that it would not as they could get conditional permits to get started, if need be.

Road Business

<u>Accounts</u>

The road accounts were presented in the amount of \$192,248.70. Moved by Besley, Seconded by Hannon that the road accounts be approved as presented by the Road Superintendent. Carried.

<u>Application for a Road Crossing - Paul L. Martin - Location of Crossing: From Lot 241, Concession 3 SW to Lot 241, Concession 2 SW</u>

Craig advised that the Township has to put a culvert in this area too and the cost is going to be about \$10,000.00. Mr. Martin wants to cross beside it so it should be done altogether but he will have to pay for some of the excavating. Mr. Martin will have to keep it approximately 10-15 feet away. Concerns were raised about where the water is going to go and Craig advised that Mr. Martin has an agreement with the landowner. Council suggested that we get a copy of that agreement to keep on file. Member Besley would like to do an onsite at the location with the Roads Sub-committee and will set this up. He was asked to let all of Council know when this was going to happen.

<u>Other</u>

Craig advised that he had been speaking with Arunas Kalinauskas from Burnside's and he does not think dropping the speed limit by 10 kms/hr on the 2nd Line SW is going to do anything and Craig said he wanted to mention this before he spent \$3,000.00 on signs. Discussion ensued and the consensus of Council was the same as the last meeting and they will be implementing a 70 km/hr speed limit on that road. This will be dealt with

later in the meeting.

Delegations

5:30 p.m. - Shirley Boxem and Lisa Needham, Headwaters Community In Action attended Council and presented and reviewed the Headwaters Food Charter and Action Plan with Council and requested endorsement from Council for the Food Charter. It was also mentioned during this time that Melancthon is in the early process of developing our Strategic Plan and would really appreciate the input from HCIA.

Moved by Elliott, Seconded by Webster that the Township of Melancthon endorses the Headwaters Food Charter. Carried.

Ms. Needham advised that they would come back to Council to update them on the implementation of the Food Charter.

Police Services Board Matters

It was reminded that there is a Community Policing Meeting - Tuesday, June 6th, 2017 at the Horning's Mills Community Hall - 7:00-9:00 p.m.

Councillor Besley who sits on the Police Services Board advised that he had been speaking with Chair Thwaites with regards to the speed limit reductions on the 3rd Line and 2nd Line SW and he would like to place the speed indicator signs in those two locations for a week or so at least. Council had no problem with this request.

By-law to Prescribe Lower Rates of Speed - 3rd Line OS from Highway 10 to 15 Sideroad

Moved by Hannon, Seconded by Besley that leave be given to introduce a By-law to prescribe lower rates of speed on the 3rd Line OS from Provincial Highway No. 10 to 15 Sideroad and it be hereby read a first and second time. Carried. By-law numbered 20-2017 and read a first and second time.

New/Other Business/Additions

Fluney Drainage Works

Donald and Kevin Fluney were in attendance for this item of business. Discussion ensued about this drain and the issue with the 10-15 acres that was stripped that is not draining and is under water. In the construction of the drain, this land was stripped and hauled away and then topsoil brought in. The land is so compacted that now there is no natural filtration to let the water get away. It was also noted that this land will take years to rejuvenate to get it back to viable farmland. Mayor White, Councillor Besley and Councillor Hannon have been to the site to see the issues. Mr. Fluney noted that the land is now lower there than before the construction and there needs to be loads of topsoil brought in to bring it back up. It was suggested that the Clerk contact Sid Vander Veen at OMAFRA to see what can be done to fix this problem. Council would like a site meeting set up with Mr. Vander Veen, Council, Staff, Tom Pridham, Drainage Engineer and the Fluney's to get this problem rectified. Mr. Fluney provided the Township with pictures of the water lying in his field.

A letter was received from EH!tel who is requesting a letter of support from Melancthon Township for the Connect to Innovate funding program. Council advised that they would lend their support to EH!tel and asked the Clerk to draft a letter of support.

Moved by Elliott, Seconded by Besley that the Corporation replace Mayor White on the NVCA with Councillor Webster until the end of the Mayor's term as County Warden. Carried.
