Moved by Besley, Seconded by Webster that the CAO/Clerk be directed to amend the Employee Recognition Policy as follows:

18. <u>Employee Recognition Policy</u>

In recognition of dedicated service to the Citizens of Melancthon Township, all part-time employees with five (5) years of service and thereafter in five (5) year increments, shall receive a certificate (wooden plaque after 20 years of service) and \$10.00 per year of service. All full-time employees with five (5) years of service and thereafter in five (5) year increments, shall receive a certificate (wooden plaque after 20 years) and \$20.00 per year of service. Retirement gift as appropriate. Carried.

3. Addition - Horning's Mills Park Board Financial Request

Deputy Mayor Elliott and Councillor Webster requested a grant in the amount of \$1,500.00 to provide a bigger fireworks display because the Township is celebrating its 165th Anniversary this year. They also advised Council of the other ideas they have for the celebration.

Moved by Hannon, Seconded by Besley that the Township of Melancthon support the 165th Anniversary Horning's Mills Park Celebration to the amount of \$1,500.00. Carried.

5:30 p.m. - Janet Horner, NEC Representative and Mulmur Township Councillor attended Council on an invitation by Council and she spoke on the Niagara Escarpment Commission

and explained the composition of the Commission, the process when applying for a development permit and the legislative and regulatory framework. Ms. Horner also shared her experience and knowledge with Council when Mulmur Council dealt with the second dwellings in Mulmur and provided an information sheet to Council. Mayor White thanked Ms. Horner for attending our meeting.

5:45 p.m. - Guy Gardhouse, GRCA Representative attended Council on an invitation by Council regarding the fill issue on Highway 89 in Amaranth Township and Annual Update of GRCA Activities. Mr. Gardhouse indicated that things were going well at the GRCA and that they are the 2nd largest in Ontario with camping. The budget for 2018 has been passed.

With regards to the fill issue on Highway 89, he advised that this started approximately 2-4 years ago. They took the peat out and brought fill in. The GRCA took the owners to Court and it was thrown out. It is now in front of the Courts again. Amaranth will be having a meeting with the GRCA next week. As of May 2017, lower tier municipalities can go into the regulated areas with their site alteration by-laws for fill violations. Mr. Gardhouse will make sure that the Conservation Authority is made aware of the well-head protection area in our municipality which are in close proximity to this area.
