8. OPP Oral Report

- a. Project Lifesaver International Update
 - Peel Region Health is looking for a Community Agency to spearhead this initiative
 - DC S/S Randall asked PC Joe Brisboise to contact Dufferin Caledon Victim Services to see if they would participate and try to launch joint program with Dufferin and Caledon OPP for purposes of this project.. ACTION: DC S/S Nicol Randall will follow up
 - Lori Martin at Metroland Media took on the project for Simcoe and is willing to speak with anyone wishing to take on this project.

b. POA Update

- DC S/S Nicol Randal conveys that the Courts will remain in Orangeville and from the OPP perspective this matter is resolved.
- The Joint PSB is pleased to see the actions of recent developments with POA courts and the POA office. Further, we would strongly recommend that the POA Board be represented by elected officials of each Municipality and one similar agreement be put in place for all Municipalities.

c. Towing/Anti-Chasing By-Law

- Amaranth is drafting an Anti-Chasing By-Law template and will circulate for further agreement and discussion.
- Kerstin Vroom will circulate a copy of the Police Services Act, which states that Police Services Boards, may create By-Laws
- It was noted that a Tow Operator, must be on the list of The Dufferin Towing Association for the OPP to use their services.

d. Marijuana Legalization/Laws Update

- Training of officers is extremely expensive.
- OPP has implemented Standard Field Sobriety Testing training across the Region, each detachment will have at least two members.
- OPP Dufferin has one member selected for the Drug Recognition Expert training
- Roadside Screening Devices will not be available until 2019.
- ACTION: DC S/S Nicol Randal to investigate the cost, if any to Municipalities.

- e. Missing Persons Update (Mulmur Request) same as (a)
- f. Area Break Ins (Mulmur Request)
 - Investigation into break ins is very active.
 - Prevention strategies: PC Paul has conducted 2 Safeguard audits, and 3 community meetings in regard to safety.
 - Officers have received patrol direction to increase visibility.
- g. Weight Load Scales Update
 - Training of Officers continues
 - Municipalities can call OPP 1-888-310-1122 to report infractions.
- h. Road Safety Update
 - Collision Reduction Strategy Continues
 - The newly erected sign on Airport Road is not working.
 - ACTION: DC S/S Nicol Randall will investigate.
 - Quantity of Collisions has remained consistent
 - Number of persons injured collisions have increased
 - Number of fatal MVC have increased
 - Response:
 - Traffic management plan
 - Collision analysis Airport Rd and Hwy 89
 - · Directed patrol based on analysis
 - Obtain new radar and LIDAR units
 - Officer training in LIDAR (re new Sgts who are trainers)
- i. Saler Ontario Act Update (Melancthon Request)
 - The legislation has received Royal Assent however it will only come into force on a day to be named by the Lieutenant Governor. Many sections rely on regulations yet to be defined. Part XIII may require the development of risk plans.
 - o Part III

The regulations may provide that a prescribed policing provider is to provide a policing function in an area, instead of or along with the Commissioner.

- Part IV (Municipal Policing and Police Service Boards)
 - Where there is a request for policing services arrangements to be provided to non-contiguous areas, the request will be reviewed by the Minister.
 - o There is no specific provision in the *Act* that speaks to an agreement between a municipal council and the Minister for OPP policing services. (Municipalities may constitute a municipal -board and maintain a police service. The Commissioner has policing responsibility for every area outside police service board responsibility. Section 64(1) also states that a municipality in the area for which the Commissioner has policing

- responsibility shall pay the Minister of Finance for the policing the Commissioner provides).
- o Further there do not appear to be provisions for municipal police services that amalgamate to the OPP.

Part XIII (Community Safety and Well-Being Plans)

- Community safety and well-being plan a requirement for municipalities;
 First Nations may also choose to do so
- These plans must identify risk factors to the community and identify strategies to reduce prioritized risk factors
- Amongst other membership requirements; an employee of the municipality or a member of the municipal council, and a police service board member or the local OPP detachment commander must sit on the advisory committee.
- 9. Responsibilities for PSB Members –(Amaranth Request)
 - Training for Board Members: (comments from Municipal Policing Bureau)
 - We do not know the composition of the detachment boards at this time until the regulations are written.
 - Normally MCSCS (Public Safety Correspondence Division) delivers any training that is related to the PSB.
 - It might be best for them to contact their Advisor, although there are still too many unknowns at this time.

I am pleased to share with you the Special Investigations Unit's 2017 Annual Report. The Report provides an overview of the SIU's key initiatives, investigation statistics, and significant cases handled by the Unit over the past year. Please note that all content in the Report is for 2017 except for the financial data, which reflect the fiscal year 2017-18.

As you may already be aware, the Special Investigations Unit is a civilian law enforcement agency — created in 1990 — with the mission of nurturing public confidence in policing by ensuring that police conduct in cases which fall under SIU jurisdiction is subject to rigorous and independent investigation. The Unit is mandated with investigating incidents involving police that have resulted in serious injury, death, or an allegation of sexual assault. The SIU Director is empowered with the authority to investigate and, where there are reasonable grounds to do so charge police officers with a criminal offence.
