Applications for Consent

B13/19 - Sandy Boodram Kissoon-Singh & Jean Sheila Kissoon-Singh

A public meeting had been called for 6:00 p.m. to consider an application by Sandy Boodram Kissoon-Singh & Jean Sheila Kissoon-Singh to sever approximately 2.47 hectares from Part of Lot 15, Concession 3 N.E., RP 7R3424 Part 1. Everett Lusk (agent for the applicants) and the applicants were in attendance. The Secretary advised submissions had been received from the Grand River Conservation Authority, County of Dufferin Building Department and County Planning Department. Chris Jones, Municipal Planning Services Ltd. reviewed his report with the Committee. He advised the proposed lot would have a frontage of 93 metres (305 feet) and a lot area of 2.47 hectares, (6 acres) and the retained lands would have a frontage of 100 metres and a lot area of 18.14 hectares (44.8 acres). The proposed lands to be severed are located in the Rural designation of the Official Plan. The proposed consent appears to be in conformity with Section 5.3.3(d) of the Official Plan, which permits the creation of up to 3 lots from and original Township surveyed lot, provided the subject lands have not been utilized for agricultural purposed for a minimum of 10 years prior to the application for consent. If the proposed consent is approved it would represent the 2nd lot created from the original parcel.

Moved by Thwaites, Seconded by Hannon that Application B13/19 to sever approximately 2.47 hectares (6) acres from Part of Lot 15, Concession 3 NE be approved subject to the following conditions:

- 1. A reference plan of survey is required. Draft survey to be provided to the Township for review prior to registration.
- 2. That the severed lot be rezoned to a Rural Residential (RR) Zone and the retained parcel be rezoned to a General Agricultural Exception Zone.
- 3. Written approval from the County of Dufferin Building Department that the severed lot is suitable for a septic system.
- 4. That the existing building located on the severed lot be removed before the deed is submitted for endorsement.
- 5. That an entrance to the severed parcel be approved by the Township's Public Works Superintendent and the entrance installed before the deed is submitted for endorsement.
- 6. That a County Rural Civic Address be assigned to the entrance on the severed parcel by the County of Dufferin and the sign be installed before the Deed is submitted for endorsement.
- 7. Taxes and special charges must be paid to date when the deed is submitted for endorsement.
- 8. Conditions must be fulfilled and deeds stamped by the Secretary on or before one year from the mailing date of the Notice of Decision, as signed by the Secretary.

This application conforms with the Official Plan of the Township of Melancthon. Carried.
