The Council of the Corporation of the Township of Melancthon held a meeting on the 21st day of November, 2019 at 5:00 p.m. in the Council Chambers. Mayor D. White, Deputy Mayor D. Besley, Councillor W. Hannon, Councillor M. Mercer and Councillor D. Thwaites were present. Denise Holmes, CAO/Clerk and Wendy Atkinson, Treasurer/Deputy Clerk were also present. Mayor White presided and called the meeting to order.

Announcements

Public Works

Report of Kaitlin Chessell, Recommendations from the Roads Sub-Committee meeting held on November 13, 2019

Deputy Mayor Besley, who is Chair of the Roads Sub-Committee, spoke to the recommendation which is to recommend that stop signs be placed on 5th Line OS at 15

Sideroad and on 2nd Line SW at 250 Sideroad. This recommendation came as a result of reviewing traffic count data indicating a lot of speeding occurring on these roads and it was thought that placing stop signs would be a good traffic calming measure. With regards to the 5th Line OS stop sign, it was suggested that another road count be done in the Spring before a By-law is brought to Council. It was also noted that this is not a good area in the winter time with the blowing snow. With regards to the stop sign on 2nd Line SW, this will become effective April 1st, 2020. Stop ahead signs will also be erected.

Detailed Deck Condition Survey Report on Structure 13 Riverview Bridge from RJ Burnside and Associates (if available)

<u>Other</u>

Mayor White suggested that with the new funding announcement (Municipal Modernization Program Intake 1), that the Township apply for Intake 1 and continue on with the Road Management Plan and have the rest of the roads studied in the Township. Deadline for Intake 1 is December 6th. It was noted that Arunas Kalinauskas, RJ Burnside and Associates, is being invited back to the next Roads Sub-Committee meeting, as the Roads Sub-Committee has some issues relating to maintenance on roads that were not in the Plan, and they would like to follow up with him on that matter.

Planning

Chris Jones, Township Planning Consultant was in attendance.

<u>Report from Chris Jones - Application for ZBA - Lot 20, Concession 4 NE (Tripp/Serbin) &</u> <u>Notice of Intent to Pass By-law - By-law to amend Zoning with respect to lands located in</u> <u>Part of Lot 20, Concession 4 NE (Tripp/Serbin)</u>

Chris Jones spoke to his Report and the Zoning By–law Amendment and went through the sequence of events relating to the application. Concerns were raised that it was recommended now as a permanent use instead of temporary use, there were concerns with future livestock in the area, concerns that precedents have already been set for 3-year temporary use for businesses in the Township and that this use does not fit in the rural area. It was also noted that some members are not against the use, just in favour of a temporary use.

Council deferred this zoning by-law amendment and directed Chris to bring a temporary use zoning by-law amendment to the next meeting.

Notice of Intent to Pass By-law - By-law to amend Zoning for the Township of Melancthon to define and regulate cannabis facilities

Chris Jones advised that there were some minor revisions made to the draft Zoning By-law Amendment as a result of comments received at the Public Meeting. Discussion ensued about a question asked at the last meeting about other cannabis crops and could they be brought to the processing facility under this By-law, and Chris advised that the By-law would not preclude it, but that approvals would have to be obtained from the Federal Government for that purpose.

Moved by Besley, Seconded by White that leave be given to introduce a By-law to amend

By-law 12-1979, as amended, to define and regulate cannabis facilities and it be hereby read a first and second time. Carried. By-law numbered 47-2019.

<u>Other</u>

Chris advised that NWN Scientific has submitted a revised set of plans under its Site Plan Application, which Craig Micks has reviewed. Chris should have a Report for the next meeting on this matter.

Climate Change Initiatives

Staff directed to continue on with items that have been previously discussed such as replacing lights in the Municipal Office and taking the Public Works Department and Administration Department off the grid. Staff to investigate grants to do this.

Deputy Mayor Besley - Turbines - Contract being terminated

There has been information in the news where the Provincial Government is terminating contracts for wind turbines and taking some of them down and where does that leave Melancthon with 167 turbines? It was noted that the ones being taken down are not commissioned. It was suggested that Sylvia Jones, MPP be invited back to Council to provide an update as she didn't have a lot of information about this when asked in May (when she had attended Council). Mayor White offered to address this with MPP Jones.
