### Unfinished Business - 2020 Draft Capital and Operating Budgets

### 2020 Budget - Continued

Wendy was asked to provide Council with year to date revenue and revenue projections for the May 7<sup>th</sup> meeting. Staff will contact both the Shelburne and Dundalk Agricultural Societies to see what their plans are for this year. Discussion regarding the reconstruction of the 2<sup>nd</sup> Line SW – top and bottom end and after discussion it was decided that it would be tendered separately with a clause that the Township may not be able to award the tender for both sections. The Horning's Mills Community Hall contribution approved at the meeting on March 19<sup>th</sup> was discussed and it was Moved by Thwaites, Seconded by White that Staff be directed to remove the grant in the amount of \$5,000.00 from the budget for the Horning's Mills Community Hall. Discussion ensued before the vote was called and then the motion carried. There was further discussion on this matter and Councillor Mercer voiced her concerns about the removal of this grant. Mayor White advised that the grant could be reinstated later and that she could bring a notice of motion for the next meeting.

### Spring Gravel Tenders - Continued

Craig Micks, Public Works Superintendent recommended the Council accept the tender from Fleshcon.

Moved by Thwaites, Seconded by White that the Council of the Corporation of the Township of Melancthon accept the tender from Fleshcon to supply and deliver approximately 20,000 tonnes of M Gravel, 5/8" and 10,000 tonnes of Granular A Gravel from Pit location Osprey and Radly. The gravel is to meet the Ontario Provincial Standards Specifications and test to be paid by contractor, with sample being supplied by the Township's Public Works Superintendent. Start time approximately May 21, 2020. The accepted prices of the tender are as follows: M Gravel - \$7.95 per tonne + \$1.03 tax and Trucking \$3.35 per tonne + \$0.43 tax. This procurement complies with the Procurement By-law for the Township of Melancthon. Carried.
