1. Road Management Plan

The Roads Sub-Committee asked Craig Micks, Public Works Superintendent his opinion on whether we should be doing the 2nd Line SW from 250 Sideroad North or the 5th Line OS between County Road 17 and 280 Sideroad. Craig said that he thinks we should be doing the 2nd Line SW as it is in worse shape and they spent three days cold patching that portion of the road already this year. The Roads Sub-Committee directed Denise Holmes CAO/Clerk to send a letter to the Township of Southgate letting them know the road issues we are dealing with from a majority of their traffic.

Recommendation:

The Roads Sub-Committee recommends to Council that we follow the Road Management Plan and complete the two sections on the 2nd Line SW this year.

The tendering process for this was then discussed and Craig commented that from talking to Arunas Kalinauskas at RJ Burnside and Associates that we should be tendering this in two different stages. We could tender the grinding of the asphalt and the paving & Geo-Grid separately and the Public Works Department can do the graveling and packing. It was discussed that we would do the top and bottom of the 2nd Line SW at the same time.
