
We can discuss at Roads Committee.

1.0 Progress of Construction

- 1.1 August 10, 2020 Distribution Slab Pour
- 1.1.1 Contractor completed placement of distribution slab.
- 1.1.2 11.5 cu.m of concrete ordered.
- 1.1.3 Concrete tested and cylinders cast.

Slump – 110mm Air – 9% Temperature – 28°C

remperature – 20 C

- 1.1.4 Burnside requested concrete to be covered with wet burlap and poly for weather protection.
- 1.1.5 Submerged pumps have been removed and culvert has filled in with water.
- 1.2 August 12, 2020 Road Reconstruction and Shoulder Layout
- 1.2.1 Contractor completed centerline layout and shoulder offset.
- 1.2.2 Contractor removing fill and tree stumps.
- 1.2.3 Contractor completed structure backfill and frost taper on east and west approaches.
- 1.2.4 Contractor completed removal of bypass culvert and restored natural channel through structure.

1.3.1	Grading operator from Township onsite completing centerline grading for Contractor to set guiderail height.

- 1.3.2 Contractor has set string lines for guiderail post installation and taper for end treatment.
- 1.3.3 Guiderail and posts have been delivered to site.

August 17, 2020 - Guiderail Lavout

- 1.3.4 Seed, erosion control blankets and hay bales have been installed on disturbed slopes.
- 1.3.5 Silt fence has been reinstated at all four quadrants.

1.4 August 19, 2020 – Guiderail Installation

- 1.4.1 Contractor completed installation of long span treatment and type M guiderail posts.
- 1.4.2 Contractor installing end treatments on all four quadrants.
- 1.4.3 Contractor has installed plastic and wooden offset block on wooden posts on south side of structure due to post installation location.

1.5 August 21, 2020 – Demobilization

- 1.5.1 Contractor has demobilized from site and opened road to traffic.
- 1.5.2 Substantial Performance Date recorded as August 21, 2020.
- 1.5.3 Contractor still required to complete concrete cleanup/chipping on distribution slab
- 1.5.4 Contractor still required to install hazard warning signs and plow markers in front of guiderail end treatments
- 1.5.5 Guiderail installation complete however more granular material on shoulders is required.

Wendy,

I just got off the phone with Glenn. Here is what we are thinking will be required for Church Street to try and take as much water as possible from flowing out on to the street.

- Ditches on the north side of the road
- Culverts under the driveways on the north side of the road
- Catch Basin at Main Street to capture the water coming down along Church Street and linking into the storm sewer system along Main Street
- Raise the road surface a little would be good for us to do a survey of the area to get appropriate levels, but we
 are also conscious of costs to the Township. Raising the road surface will help to push the water into the new
 ditches.
- Asphalt road surface and Asphalt gutters

I am sorry but we are really busy and will not be able to provide a cost estimate for all of this extra work today. We will do our best to try and get a cost estimate out as soon as we can. I am expecting this might be a week or more. Usually we can put some things aside and work up a cost estimate but this one has some critical parts and we want to make sure it has the details that are needed.

Soon as we have the cost estimate worked up we will send it on to you.

The Roads Sub-Committee held a meeting on August 19, 2020 and one of the items on the agenda was the resurfacing of Church Street.

The Road Management Plan has Church Street scheduled for rehabilitation in 2024 with an estimate of \$31,460.

The Committee discussed the work that would be needed and feel it should be looked at with an engineer as there are curve and drainage issues and

Craig feels a storm drain may be required. The Committee has asked that I contact you and request an costing update with engineering costs included

and if there are any environmental impacts to consider and why this was not scheduled until 2024 when they feel the road is in current need of repair.

The Committee doesn't feel that the estimate of \$31,460 will cover the required upgrades.
