## **1. Update from Public Works Superintendent**

Craig Micks, Public Works Superintendent advised that they have been out grading roads, they have removed the plows from the trucks and have been picking up a lot of roadside garbage. Member Hannon asked Craig to look at the road crossing culvert South of County Road 21 on the 5<sup>th</sup> Line OS as it appears to be clogged possibly by a beaver and the water is high.

# 2. Eh!Tel Networks Inc – Installation of Fibre Optic Internet Infrastructure in the Municipal Road Allowance

Craig advised that he has been in contact with Eh!Tel about this. Scott Burns, County of Dufferin sent out an email on how they recommend Municipalities deal with this and they are advising it to be installed along the lot lines of properties in the municipal ditch. John Willmetts, from the Township of Mulmur advised Craig that they are asking Eh!Tel to install on the shoulders of the roads as when ditching they do not want to have to worry about digging up the Eh!Tel lines. Craig advised that his preference would be for them to install on the shoulders of the roads as well. They want to begin install the middle of June and will be boring the holes.

# **3. Entrance Permit Fee**

The Entrance Permit Application fee is current \$300.00 (\$100.00 fee plus a \$200.00 deposit) which is refundable upon completion. Craig Micks, Public Works Superintendent is making multiple trips to each entrance and the \$100.00 portion of the fee that we keep is not covering his costs. It was discussed that we increase the fee to \$500.00 (\$300.00 fee plus a \$200.00 deposit).
