Mr. Patchett retained the services of PJ Williams, Ontario Land Surveyor to prepare his survey, as part of the conditions of his Consent approval.

The draft reference plan was submitted to the Township on March 19, 2021 for the Township's Preliminary Review.

Chris Jones, Township Planning Consultant noted a couple of issues with the draft survey with one of them of the most concern being Mr. Patchett's well encroaching on the retained land.

The draft survey was amended by Mr. Williams and the property line adjustment will have an 8mx8m box around the well, to be included in the Part 3 area on the Plan. Please see attachments to this memo.

Chris Jones is satisfied with this modification, but wanted the matter placed on the Agenda to make the Committee of Adjustment aware of this issue, before final approval is given on the draft reference plan.
