Chris Jones advised that he prefer to look at a Hobby Farm Regulation By-law to deal with other animals on smaller acreages and will bring a Report back to Council on it.

At the Council meeting held on March 4, 2021, during budget discussion, it was requested that if there was a surplus as a result of the 2020 Consolidated Financial Statements then the amount allocated to the Road Equipment Replacement Reserve be brought up to \$150,000.00 as the budget only allocated \$100,000.00 to the Road Equipment Replacement Reserve.
