Roads Committee- 5th Line

Having had the opportunity to drive along a section of 5th Line this afternoon. I wonder whether the Roads Committee is considering placing a traffic/speed counter out to measure the impact of the recent construction.

It would seem that the gravelled road should be reconsidered as part of the Road plan given that the previous real challenge of excessive speeding might have found at least a partial answer.

I note that with the anticipated completion of paving of County Road 21 that there will be a good option for a travelled paved road between 124 and 10.

It is my recollection that traffic volume on 5th was not high in previous years.

If the results of a traffic/speed counter demonstrated, using the comparables from previous years, a marked decrease in speed then an argument might well be made for maintaining 5th in gravel as opposed to asphalt. (I recognize there are other factors that may well weigh into the decision process but it might also be a consideration that a newly paved road will invite a race track).

Just a thought/idea, at least the Committee will have taken the opportunity to obtain the evidence to support recommendations/decisions.
