Report from Denise Holmes, CAO/Clerk on behalf of the Horning's Mills Community Park Board of Management regarding Purchase and Installation of Bleachers

There was discussion on the recommendation and the following motion was introduced and passed:

Moved by McLean, Seconded by White that Council accept the recommendation from the Horning's Mills Community Park Board of Management and approve the purchase of a 5 Row GTG Aluminum Bleacher with Mid-Aisle & Guardrail, 15' long, double footboard in the amount of \$12,118.11 (HST included), and the purchase of concrete in the amount of \$1,130.00 (HST included) for the installation. The bleachers to be installed by Kevin Fawcett and the Township Public Works Department. The monies to cover the cost of the purchase of the bleachers and concrete will come from donations received by the Township in Memory of Mr. Doug Newell, as well as the funds that were approved, by motion, to be transferred from the Municipal Modernization Funding to the Horning's Mills Park Funding on March 5, 2020.
