To Retain Interim/Special Counsel

Moved by Mercer, Seconded by Hannon that Council retain Interim/Special Legal Counsel.

There were members not in favour of the motion as the Township already has retained lawyers that are capable of giving advice. Further discussion ensued on separating personal business from Township business on Facebook, disclaimers on Facebook posts, etc. There were suggestions of various platforms that the Public /Council could go to if it was thought there was wrongdoing i.e. – Township Integrity Commissioner, Provincial Ombudsman, Freedom of Information requests. When there was no further discussion on this motion, Mayor White called for a recorded vote on the motion:
