

#### Hello Donna

I'm not the expert on how a weed gets on the Noxious weed list. This is a good question for our Weed Inspector or Mike Cowbrough.

Mike Cowbrough Weed Specialist (Field Crops) **Chief Inspector (Weed Control Act)** Ontario Ministry of Agriculture, Food and Rural Affairs 519-820-2336

Phragmites is on the invasive list. Maybe the committee should look at all the invasive on the list and determine a wholistic approach. I recommend starting with finding and mapping all the locations on Municipal land and then determine an approach to deal with phragmites. This is particularly important to control the spread in the road allowance. Once council is on board to treat the road allowance the next issue is private property. This is more difficult. Educating land owners is likely the first step but then someone need to be creative.

At Dufferin we started by mapping all the locations and measuring the length and width of each area. Then we started a spraying program to control the spread. Once the weeds were dead we attempted to cut the Phragmites with a tractor with and long reach mower. The cutting helped with the sight line issues but the reach was not sufficient to cut to the property line. We were very successful in 2020 and majority of the areas were not an issue in 2021. That said we missed some areas and were not able to get a contractor in to spray for 2021. I have been told that it takes 3 years of spraying to control phrag. We had fantastic results with one year of spraying. I was very happy with the results but we did miss some areas when mapping and missed a respray of some areas in 2021. We will get them this year. Planning to re-map this year. Our approach does not get the private property. PW's limit is the property line.

Property owners in Dufferin County are responsible for destroying noxious weeds on their property that may have an impact on agricultural or horticultural land.

The Weed Control Act of Ontario states that all property owners are responsible for destroying noxious weeds on their property unless the weeds or weed seeds are deem Weed Inspector to be far enough away from any land used for agricultural or horticultural purposes that they do not interfere with that use.

Dufferin County acts on behalf of the municipalities of Amaranth, East Garafraxa, Grand Valley, Melancthon, Mono, Mulmur, and Shelburne in controlling noxious weed Residents of the Town of Orangeville should visit the Town's website for information on their weed control program.

If a property owner fails to comply with the Act, the County's Weed Inspector may have the weeds destroyed and charge the costs against the land in taxes.
