Mayor White presided and called the meeting to order.

Public Question Period

There were no written questions. There was a question from a Member of the Public who attended the Candidate session in Shelburne this afternoon asking why there was no Staff Representation from Melancthon at the session and an inquiry about Candidate information packages. Another question asked by a resident was why the County cannot

stick to the construction haul routes (on County Road 21) as well as a question on when speed limit signs will be posted on 4th Line NE.

Councillor Mercer – Addition – She read the email she received from Brenda Serbin, who is requesting a written response to her letter of April 21, 2022.

Public Works

Accounts

Craig Micks, Public Works Superintendent presented the accounts in the amount of \$105,495.12.

Moved by Neilson, Seconded by Besley that Council receive the Public Works Accounts as presented by the Public Works Superintendent. Carried.

2022 Gravel Tender Recommendation/Award

The Memorandum from Craig Micks was reviewed.

Moved by Besley, Seconded by Neilson that Council award the tender for the supply and delivery of approximately 5,000 tonnes of "M" Gravel, 5/8", 5,000 tonnes of Granular "A" Gravel and 15,000 tonnes of 19mm Limestone Crusher Run to specified roads within the Township to Flesherton Concrete Products. The gravel is to meet the Ontario Provincial Standards Specifications and test is to be paid by the contractor, with the sample being supplied by the Township's Public Works Superintendent. Start time is approximately May 16, 2022. The accepted prices of the tender are as follows: M Gravel - \$9.20 per tonne + \$1.20 HST and Trucking \$5.75 per tonne + \$.75 HST; A Gravel - \$9.10 per tonne + \$1.19 HST and Trucking \$5.75 per tonne + \$.75 HST; 19mm Limestone Crusher Run - \$9.40 per tonne + \$1.23 HST and Trucking \$5.75 per tonne + \$.75 HST; tonne + \$.75 HST. We further direct Staff to return the tender cheques to the unsuccessful bidders and thank them for their submission. This tender complies with the Procurement By-law for the Township of Melancthon. Carried.

Unfinished Business

River Road Broken Pipe – Recommendation from Roads Sub-Committee

Discussion ensued on this matter. Deputy Mayor Besley advised that the Township has received opinions from legal and insurance that the pipe is not the responsibility of the Township because there is an agreement on title from 1958 that states the owner of the property (McKellar) is responsible for all costs. Concerns were raised about the public works department hitting the pipe in 2020 but Craig Micks advised that where the pipe was hit, it was fixed. He further stated that the pipe was plugged and they unplugged it and it was working up until last fall. He advised that the water is coming up through the road and every year, the road heaves in that particular spot and the crack in the road is a far distance from where they damaged the pipe in 2020. There was further discussion about the NVCA getting involved in this matter and due to the age of the pipe that is under the road, it needs to be replaced. It was suggested that the owner could obtain a legal opinion. Ms. McKellar asked for a letter from the Township on where Council stands on the matter but there was no direction given to Staff to provide the letter. The following motion was then passed:

Moved by Besley, Seconded by Mercer that the CAO, Public Works Superintendent and Deputy Mayor Besley meet with Ms. Loretta McKellar to try and come up with an equitable solution for the next meeting. Carried.
