Good afternoon Craig,

The Contractor is working to wrap up at Bridge 11 next week and is planning to reopen the road by end of day Monday June 6th once guide rail is installed.

Below is a brief summary of the work completed at Bridge 11 up to June 1st as well as a few photos attached capturing the construction progress.

Construction Progress

- New deck drains and drain extensions have been installed;
- The bridge deck has been waterproofed;
- Road widening, padding and paving has been completed; and
- The Contractor is working to complete site restoration.

Construction Schedule

- Site restoration work to be completed by Friday June 3rd;
- Guide rail installation is scheduled for Monday June 6th; and
- The Contractor is planning to reopen the road to traffic by end of day Monday June 6th

Unfortunately, the Contractor ran into supply issues for the concrete sealer (Item D.7) and noted that they will return to site to seal the curbs, barriers and fascia at a date TBD. It is anticipated that the sealer will become available in approximately 3-6 weeks. No additional road closure will be required for application of the concrete sealer.
