Mayor White agreed and advised he would bring this matter up at the AMO Conference in August if there are any panels/round table discussions on excess soil.

Councillor Mercer provided the information she obtained from the City of Kitchener's Manager of Transportation and Planning to Council regarding lowering speed limits. 6:00 p.m. – Terry Ward, Inspector – Detachment Commander, Dufferin OPP attended Council at the invitation of Council regarding the reduction in the speed limit on 4th Line NE and to discuss the challenges that may be presented if Council passes this By-law. Inspector Ward advises that it is really up to the Mayor and Council to make the decision and they will do the enforcement piece. He did reach out to his Sergeants for feedback and input. Some of that feedback was that this section of roadway is similar to 2nd Line SW and the recommendation should be that it be consistent with that speed reduction. By reducing the speed limit on the road, it will not affect the OPP one way or another and that it is really up to Council to decide.

6:15 p.m. – A Public Meeting had been called to consider a proposed Zoning By-law Amendment on Part of Lots 7 and 8, Concession 1 O.S to modify the Open Space Recreation (OS1) –516423 County Road 124 (Samuel E. Young Golf Enterprises Ltd.). Bob Long, Agent for the Owner and Meghan Young were in attendance for the meeting. Chris Jones, Township Planner on this file, provided an overview the proposed ZBA. The Clerk advised that comments were received from the Dufferin County Building Department, Enbridge Gas and the Dufferin County Planner. Mayor White asked if the members of the public had any questions or concerns and there were none and he also

asked if any members of Council had any questions or concerns about the application and there were none. The public meeting then concluded at 6:22 p.m.
