The Council of the Corporation of the Township of Melancthon held an electronic meeting on the 15th day of September, 2022 at 5:00 p.m. Mayor Darren White, Deputy Mayor Dave Besley, Councillor Margaret Mercer, Councillor James McLean and Councillor Bill Neilson were present. Denise Holmes, CAO/Clerk and Sarah Culshaw, Treasurer/Deputy Clerk were also present. Mayor White presided and called the meeting to order.

Mayor White advised that the meeting was being recorded and would be posted to the Township's website under Council Agendas and Minutes.

Announcements

Councillor Neilson informed Council, regretfully, that he was resigning from the Multi-Municipal Wind Turbine Working Group effective immediately as it came to his attention at the last meeting that when pecuniary interest was brought up, that anyone who has a turbine on their property has a pecuniary interest. This matter will be added to the Agenda as an addition to appoint Councillor Mercer to the Group, as she is the alternate.

Mayor White – Shelburne and District Fall Fair is being held this weekend – Friday evening and Saturday and admission is free.

Recommendation # 1

Moved by Besley, Seconded by McLean that Council accept the recommendation from the Roads Sub-Committee to accept the proposal from Enbridge Gas, for them to install an asphalt pad around the emergency gas shut off at 117103 2nd Line SW as per their specifications and remove the concrete bollards. Carried.

Recommendation # 2

Moved by Neilson, Seconded by Mercer that Council accept the recommendation from the Roads Sub-Committee and directs the CAO/Clerk to sign the Agreement from Eh!Tel to allow them to install their conduit above the culvert on Mill Lane, maintaining as much depth below the grade as possible and maintaining a minimum coverage above the culvert, in order to provide their Fibre to 153 Mill Lane, Horning's Mills. Carried.

Recommendation from the September 14, 2022 Roads Sub-Committee meeting

Craig advised that the work on the 2nd Line SW was finished yesterday.

Deputy Mayor Besley provided an update on Poulton Place regarding the engineered road costing received from RJ Burnside and Associates. A lengthy discussion ensued and Craig was asked to break out some of these costs to look for savings and bring this back to the Roads Sub-Committee.

Moved by Mercer, Seconded by Besley that the Board, Committee and Working Group minutes, Items 1-4, be received as information. Carried.

During this time, Councillor McLean updated Council regarding the Horning's Mills Hall Board meeting. The Hall Board is moving forward with organizing a formal Remembrance Day Ceremony for Melancthon at the Cenotaph in Horning's Mills. Councillor McLean has reached out to the Legion to see if they can participate, as well as the Mulmur Melancthon Fire Chief, Women's Institute and OPP. He encouraged Melancthon Council and Staff to attend.

Councillor McLean also reminded Council that the Horning's Mills Hall is designated as the Emergency Shelter and he spoke about a situation last winter when the Hall wasn't utilized and stranded motorists were taken to Masonville Store. He would like the OPP reminded that it is an emergency shelter. If there is an emergency, either he or the Chair of the Board is available to open the Hall. When the Hall is to be opened as a Shelter, Dufferin County/Red Cross will be contacted for resources. As there is no emergency kit at the Hall, Councillor McLean inquired as to what we should have in an emergency kit. Staff will reach out to the County's Emergency Management Coordinator for this information. Mayor White explained about the situation last winter and the inability for Red Cross to open the Shelter properly and due to Covid, there was the decision not to open it.

Councillor Mercer raised a question about the holiday on Monday for the funeral of Her Majesty Queen Elizabeth II and it was advised that it will be a holiday for federal employees and for all others, it will be a day of mourning. There will be an event at the Shelburne Legion.

During this time, Councillor Mercer spoke to her addition to the Agenda regarding the Heritage Plaque Program and how the program will be rolled out and a picture of the plaque was shown on the screen. She thanked the Heritage Board for all of their work on the plaque program. A recommendation was sent out from Kaitlin Chessell and discussion ensued and the following motion was passed:

Moved by Mercer, Seconded by McLean that Council accept the recommendation from the Heritage Advisory Committee and directs Staff to roll out the Township of Melancthon Heritage Plaque Program on October 1, 2022 with the deadline for applications being December 1, 2022. Carried.

Councillor Neilson spoke on the Southgate Recreational Advisory Committee meeting he attended today, and advised there was nothing new to report but he did advise the Committee of the new Melancthon's Recreation Task Force.

The issue of the resignation of Councillor Neilson from the Multi-Municipal Wind Turbine Working Group was added to the Agenda and discussed during this time and the following motion was introduced and passed:

Moved by Mercer, Seconded by Besley that we accept with regret, the resignation of Councillor Bill Neilson from the Multi-Municipal Wind Turbine Working Group and appoint Councillor Margaret Mercer to fill that spot for the remainder of the term. Carried.

Councillor McLean provided an update to Council on the water situation at Primrose Elementary School that has impacted the bathroom facilities.

Discussion ensued on Board appointments, end of the term of the Boards, etc. If persons are interested in staying on Boards they can send in an email to the CAO/Clerk to be kept on file. The Board appointments notice will be published at a later date and Council appointments will be done in December. Councillor McLean commented that the Hall Board would like to add a Treasurer position to the Board to help with receiving rental fees, etc. Discussion ensued on this matter, as adding another person to the Board would require the current Agreement to be amended. The Board was asked to

make a formal request to Council for a Treasurer. In the past, a Board member was appointed as the Treasurer from within the members and it was not a separate position.

There was discussion about extending the Horning's Mills Hall Board term to the end of the year due to the activities the Board has planned between November 14th and December 31st. Staff will prepare a motion for the next meeting.

This now has to be clearly defined and will require some policies and procedures relating to abuse to be put in place. After the presentation, Council were asked if there were any questions. Mayor White declared an interest for the reason that: I am named in a lawsuit submitted by Margaret Mercer against the Township and myself. Councillor Mercer also declared an interest for the reason that: I am involved in Libel action (brought by me) against the Mayor and the Township. Both Mayor White and Councillor Mercer were put in the waiting room until the question was answered and then they were brought back into the meeting. There were questions related to cyber crime and the Township's coverage.
