- Time standards displayed are for the 2023 billing period.

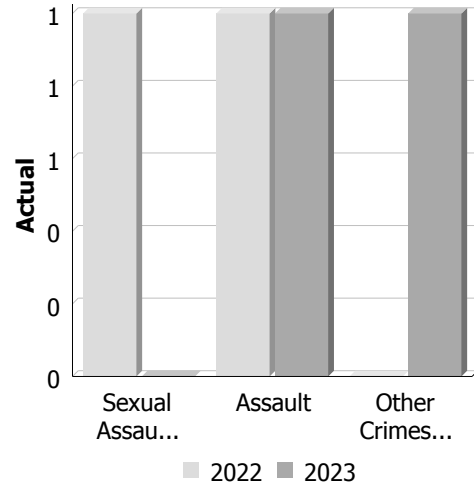

Drivers should also adjust their speed and be aware of extra vehicle traffic and pedestrian traffic during school times in school areas and zones.

#### Points to Remember

- Be aware of school buses with their yellow then red flashing lights activated. The fine for passing a school bus with its red lights activated is \$490 minimum and six demerit points.

Drivers that are found in violation will be served a Provincial Offences Notices for "Failing to stop for a School Bus" that comes with a price tag of \$490.00 and six demerit points upon conviction. ### **ENHANCING MOTORIST SAFETY THROUGH THE "SAFE ON 10" INITIATIVE**

*Wrap up - results are in*

(DUFFERIN, ON) - Several Detachments of the Ontario Provincial Police (OPP) conducted a road safety initiative with a focus on speeding and aggressive driving behaviours from September 13, to 15, 2023. Officers from Dufferin, Caledon, and Grey County OPP detachments, as well as the Central Region Traffic Incident Management Enforcement team supported by OPP Aerial Support Unit participated.

The Hwy 10 corridor runs for approximately 137 km, stretching from Brampton in the South to Owen Sound in the North. Over the past few years there has been a noticeable rise in motor vehicle collisions involving property damage and personal injury along this corridor. Aside from the volume of collisions increasing, the severity of collisions that take place on Highway 10 and other similar secondary highways is a significant factor.

This initiative was intended to raise awareness amongst motorists in relation to the inherent dangers involved in operating a motor vehicle on a secondary highway, such as intersection related and head on collisions.

The results for "Safe on 10" indicates that some motorists are still not getting the message.

## 2022 Roadways, Waterways and Trails Progress Results

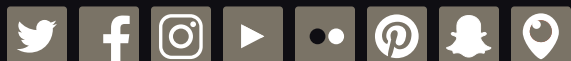

Dear Mayor/Reeve/CAO/Treasurer,

April 1, 2024, has been proclaimed as the official date on which the *Community Safety and Policing Act, 2019 (CSPA)* will come into force. At that time, it will repeal and replace the current *Police Services Act, 1990 (PSA)*. The provision of OPP municipal policing services is preserved under the CSPA, however, no municipality will remain in a contract or municipal group contract arrangement under PSA s. 10.

We wish to confirm that the OPP 2024 Annual Billing Statements remain in effect after April 1, 2024, and municipalities will continue to be billed in accordance with costs in the statements.

Under the CSPA, all municipalities policed by the OPP will be subject to Regulation 413/23 *Amount Payable by Municipalities for Policing from Ontario Provincial Police*. This regulation preserves the cost-recovery methodologies currently in effect. The OPP Billing Model cost allocation method remains the same under Reg. 413/23. There are transitional provisions included in the Regulation that stipulate that 2024 annual billing statements will not need to be reissued.

Good afternoon everyone

We held our final Mono Police Service Board under s.10 this afternoon. We have requested that the Town of Mono form a Police Service Committee that will be able to bring forward to the new "3M" Board local issues. Our current Board will also meet for a last time in June to wrap up, or at the call of the chair.

I had asked our Clerk, Fred Simpson, to engage with his counterparts to discuss the transition. He met with Roseann (Mulmur), Denise (Melancthon) on January 24<sup>th</sup> to discuss the transition to the new PSB. From that meeting they are drafting terms of reference that address:

- remuneration,
- board secretary,
- other administrative matters,
- council and community member appointments,
- election of chair.

The intent is to propose to the respective councils a process, based on the draft terms of reference, for discussions on each of these topics. Fred will be reviewing the ORR posting to see how the proposed regulation aligns with our terms of reference. Depending on the results of that review, we may have to amend the recommended terms of reference.

I also reached out to Duane Sprague for advice. I am including his response below for your info.

At this point I don't know if we need to meet, or just await the work that is being done by the Towns.

Hi Mike,

In terms of a transition period where your existing board and your new detachment board both exist to support continuity and information sharing what I can tell you is that section 10 boards will no longer have any statutory powers or duties under the PSA or CSPA once the CSPA comes into force, but they are not automatically dissolved. They may continue to exist temporarily (e.g., to deal with matters such as transferring their records before dissolving).

I'm going to suggest that you should try to identify the 3 council and 3 community reps. for the 7-member combined Melancthon, Mulmur and Mono board as soon as is possible but do not worry if this is not completed by April 1st, 2024, on the dot. Keep in mind that s. 10 boards under the CSPA only have to have a minimum of 4 meetings per year, so if it takes a bit longer to identify all board members (with the ministry addressing the 1 provincial appointee) and then setting up a meeting in May/June then that should be fine.

As far as the process for appointing provincial appointees to OPP detachment boards, we're leaving this up to our Appointments Unit to coordinate. We've been advised that existing provincial appointees to section 10 boards will need to apply for appointment to a detachment board under the new framework and persons interested in being appointed by the province to an OPP Detachment Board should ensure they have an online profile completed with the Public Appointments Secretariat (PAS). Links for OPP Detachment Board profiles are supposed to be uploaded to the PAS website by this time. I'm going to suggest that you could contact the ministry Appointment officer Jacob Estrela-Robalino at:

[Jacob.Estrela-Robalino@ontario.ca](mailto:Jacob.Estrela-Robalino@ontario.ca) to confirm the information I have. In my opinion, Wayne can stay on the board until notified otherwise.

As far as who selects the community representatives who will be on the new OPP detachment boards, in accordance with s. 67 (6) (1) of the CSPA, s. 33 applies to detachment boards and provides some guidance on member appointments. The decisions related to the appointment process for community member seats on Detachment Boards are made at the local level, this includes recruitment processes and eligibility requirements. Municipalities can develop their own processes and criteria tailored to their specific needs and circumstances when identifying the community representative members of boards.

I know this a big transition Mike and a bit of an unsettling time but I'm going to suggest that as long as your combined board can get enough members for quorum (and not worry that everything has to be done by April 1, 2024) then I'll assist with as many other details as I can with your new board. If it's any consolation, I think many other existing boards that are transitioning to an OPP Detachment Board around the province are feeling the same.

I think the idea of reaching out to other CAO's in Zone 5 is a good idea to see what other areas are doing in terms of transition processes, etc.

You folks may also want to reach out to Lisa Darling, the E.D. of the OAPSB for further information. Lisa and her team have been doing a number of presentations around the province leading up to the CSPA and it may not be a bad idea to tap into those resources as Lisa has been in close touch with our Minister and staff throughout this process.

I also know there is a CSPA Summit in Toronto at the end of this month (February 27 and 28) where the Ministry, OAPSB, OACP, PAO and PS board members will be attending and making presentations on the various transition areas of the CSPA and hopefully more questions get answered.

If I can gather any more information to assist you in this transition I will pass it along.
