CORPORATION OF THE TOWNSHIP OF MELANCTHON

BY-LAW NO. ____-2024

BEING A BY-LAW TO ESTABLISH COMMUNITY SAFETY ZONES IN THE TOWNSHIP OF MELANCTHON

WHEREAS:

- **1.** Pursuant to the Highway Traffic Act, R.S.O. 1990, Chapter H.8, Section 214.1(1), the Council of a municipality may by By-law designate a part of a highway under its jurisdiction as a Community Safety Zone, if in Council's opinion, public safety is of special concern on that part of the Highway;
- **2.** Subsection 214.1(3) of the Highway Traffic Act provides that the By-law designating a community safety zone shall specify the hours, days and months when the designation is in effect; and
- **3.** It is the opinion of the Council of the Township of Melancthon that public safety is of special concern on the part(s) of the highway(s) designated in schedules "A", "B", "C" & "D" to this By-law as Community Safety Zones;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWNSHIP OF MELANCTHON ENACTS AS FOLLOWS:

- 1. Schedules "A", "B", "C" & "D" referred to in this By-law shall form part of this By-law.
- 2. Each entry in a Column of Schedules "A", "B", "C" & "D" shall be read in conjunction with the entry or entries across from that entry or entries and not otherwise.
- 3. Where official signs are erected or placed on highways in accordance with the regulations of the *Highway Traffic Act, R.S.O. 1990, Chapter H.8,* as amended from time to time, the highways set out in Column 1 and geographic limits as defined in Column 2 and Column 3 of Schedules "A", "B", "C" & "D" attached hereto are hereby designated as Community Safety Zones and shall be enforced during the period of time as set out in Column 4 to the said Schedules.
- 4. In the event any provision, or part thereof, of this By-law, including Schedules "A", "B", "C" & "D", is found by a court of competent jurisdiction, to be ultra vires, such provision, or part thereof, shall be deemed to be severed, and the remaining portion of such provision and all provisions of this By-law including the Schedules shall remain in full force and effect.
- 5. Any person violating any of the provisions of this By-law is guilty of an offence and on conviction is liable to the penalty as outlined in the Highway Traffic Act.
- 6. Where this By-law conflicts with any other By-law of the Township of Melancthon, this By-law prevails to the extent of the conflict.
- 7. That By-laws 14-2008 and 17-2024, and any other By-laws inconsistent herewith, are hereby repealed upon the date this By-law comes into force and effect.
