That correspondence items 1-7, for information purposes be received as information, except for item 4, pulled for further discussion. Carried.

Councillor Neilson pulled # 4 and wondered if there was any appetite to make a donation. Council concurred and Staff were directed to purchase a 1/4 ad in the Military Service Recognition Book.

Councillor Neilson advised that Shelburne and District Fire Board met on Tuesday night and there was discussion on the budget that has come in at 16 percent. There is \$100,000 placeholder for engineering for a new fire hall, the new radio system is now \$100,000 – was originally \$80,000. He noted that one municipality has backed out, so the rest of the municipalities need to make up the difference for the new radio system. Councillor Neilson advised that the Fire Service Review was not well received, three of the municipalities out of the five do not want to go with a County of Dufferin model. They looked at the North Dufferin model as they don't believe status quo is going to work. The next meeting will be dedicated for further discussion to look at a North Dufferin Fire Department. There was further discussion on this and the consensus of Council is that looking at a North Dufferin Fire Department is premature at this time until we have a conversation at County Council.

## **Items for Council Action**

1. Family Transition Place – Woman Abuse Prevention Month/Wrapped in Courage Campaign Proclamation

That WHEREAS November is Woman Abuse Prevention Month and November 25th is the International Day for the Elimination of Violence Against Women; and WHEREAS violence is the greatest gender inequality rights issue for women, girls and genderdiverse individuals. Our community is committed to ending femicide and all forms of gender-based violence; and WHEREAS Femicide rates are on the rise in Ontario, with over 52 femicides in Ontario since November 26th, 2023; and WHEREAS last year in Ontario, on average every 6 days a woman or child lost their lives due to men's violence; and WHEREAS Indigenous, Black, South Asian and Southeast Asian women and girls continue to experience high rates of violence, including femicide, on the 2022-2023 Ontario Femicide List; and WHEREAS this month and throughout the 16 Days of Activism Against Gender-Based Violence, we acknowledge our community's support of the Wrapped in Courage campaign and commitment to ending gender-based violence; and WHEREAS there is an urgent need for greater investment and action to end gender-based violence in our community and throughout Ontario by all three levels of Government; and Now, therefore, I Darren White, on behalf of the Council of the Corporation of the Township of Melancthon proclaim and declare that November 25th, 2024, shall be known as "The International Day for the Elimination of Violence **Against Women**" and urge all citizens to recognize this day by taking action.

2. Shelburne Public Library Approved 2025 Draft Budget

Discussion ensued and Melancthon's levy is up due to increased number of households. Staff will get this information and send it out to Council. Staff were directed to include the levy in the 2025 Budget.

By-law to amend By-law No. 57-2023, a By-law to appoint a Municipal Services Board for the Horning's Mills Community Hall

That leave be given to introduce a By-law to amend By-law No. 57-2023, a Bylaw to appoint a Municipal Services Board for the Horning's Mills Community Hall and it be hereby read a first and second time and numbered 43-2024. Carried.

### New/Other Business/Additions

1. Significant Events Notification – SDFD and MMFD

Councillor Neilson spoke to this matter and advised the Fire Chief of the Shelburne and District Fire Department sent out an email to the Fire Board regarding a significant event in Amaranth Township. The email is exactly the information that Council is looking to receive. Staff were asked to reach out to Fire Chief Pratt and ask that the emails also be sent to the CAOs. Staff will also reach out to the Mulmur Melancthon Fire Department and Southgate Fire Department requesting that those Fire Chiefs follow the approach taken by Shelburne and to include the CAOs.

2. Additions – Councillor Plowright Motion – County Road 17 – Temporary Traffic Calming Measures

## Moved by Plowright, Seconded by Neilson

Whereas Melancthon Township has experienced a series of tragic motor vehicle collisions at the corner of Highway 10 and County Road 17; and Whereas traffic volume is increasing through Melancthon, making collisions more frequent in the Township; and Whereas the existing two way stop sign is insufficient in addressing the challenge of impatient and distracted motorists; and Whereas the province is responsible for the intersection in question; and Whereas Dufferin County has a moral duty to advance road safety on all of its roads, regardless of whether specific intersections belong to the County or not. Now Therefore Be It Resolved that Melancthon Council requests the County of Dufferin to identify suitable temporary traffic calming measures on County Road 17 to make the road safer; and Further that the County invite a senior representative from the Ministry of Transportation to appear at the Infrastructure and Environmental Services Committee to discuss the hazardous intersection in question, including the possibility of erecting a set of traffic lights or building a roundabout.

Councillor Plowright spoke about her motion and the reason why she put it forth. Mayor White made a friendly amendment to the third Whereas and the amendment was to remove the words "belong to" and change it to "are under the control of". Council also added another paragraph at the end of the motion to ask that the motion be circulated to Dufferin OPP Detachment Board – Melancthon, Mono, Mulmur; Dufferin OPP Detachment Board – Orangeville; Dufferin OPP Detachment Board – Shelburne; Dufferin OPP Detachment Board – Amaranth, Grand Valley, East Garafraxa; All municipalities in Dufferin County; Township of Southgate; Municipality of Grey Highlands; Sylvia Jones, MPP – Dufferin-Caledon."

## The amended motion to read:

Mayor White called for the vote and the motion was carried.

Tabled Motion from the May 2, 2024 Council Meeting – Dissolving the Horning's' Mills Park Board and the Corbetton Park Bord to Establish a Melancthon Park Board

## Moved by McLean, Seconded by Neilson

That Council for the Melancthon Township dissolve the Horning's Mills Community Park Board and Corbetton Park Board effective July 15, 2024 ;And further that the Council for Melancthon Township establish a new Melancthon Park Board that will oversee the activities and upgrades at the Horning's Mills Community Park, Corbetton Park and the Township properties in Riverview; And further that a new Terms of Reference be created by the Board, to reflect the new Board; And further that the membership on the new Board will be expanded to include 7 members of the public and 2 members of Council with recruitment of the new Board to begin on July 15, 2024.

Discussion ensued and because the dates have passed in the motion, the motion was amended to change the date in the first paragraph to January 1, 2025 and to delete the last paragraph of the motion entirely.

Mayor White called for the vote and the motion was carried.

### **Delegations/Public Meeting**

The following Planning Public Meeting took place during the meeting.

5:20 p.m. – A public meeting had been called for a proposed Zoning By-law Amendment on Part of Lot 14, Concession 5 NE. The purpose of the proposed amendment is to rezone the subject lands that are legally described as Part of Lot 14, Concession 5 NE – RP7R-6896, Part 1 from General Agricultural (A1) and Open Space Conservation (OS2) to Rural Residential – Exception (RR-176) and Open Space Conservation (OS2). The Clerk advised that comments had been received from Enbridge Gas and the Grand River Conservation Authority. Liam Morgan, Development Planner, was in attendance and spoke to his Report that was in the package. Beverly Nicholson, Planner for the applicant was in attendance, as well as Cheri Yap, Applicant. Ms. Nicolson spoke to the application. Harvey Lyon was in attendance and spoke about his concerns about the delay in this process. As there were no other concerns from Council or the public, the meeting was adjourned.
