Councillor Neilson spoke to # 9 and requested that Council support the motion.

Moved by Neilson, Seconded by McLean

WHEREAS official statistics from the Government of Ontario confirm that rural roads are inherently more dangerous than other roads;

AND WHEREAS, despite only having 17% of the population, 55% of the road fatalities occur on rural roads;

AND WHEREAS, rural, northern, and remote municipalities are fiscally strained by maintaining extensive road networks on a smaller tax base;

AND WHEREAS, preventing crashes reduces the burden on Ontario's already strained rural health care system;

AND WHEREAS, roadway collisions and associated lawsuits are significant factors in runaway municipal insurance premiums. Preventing crashes can have a significant impact in improving municipal risk profiles;

THEREFORE, BE IT RESOLVED THAT the Township of Melancthon requests that the Government of Ontario take action to implement the rural road safety program that Good Roads has committed to lead. It will allow Ontario's rural municipalities to make the critical investments needed to reduce the high number of people being killed and seriously injured on Ontario's rural roads; and

FURTHER THAT a copy of this resolution be forwarded to Premier Doug Ford, Hon. Prabmeet Sarkaria, Minister of Transportation, Hon. Kinga Surma, Minister of Infrastructure, Hon. Rob Flack, Minister of Agriculture, Hon. Lisa Thompson, Minister of Rural Affairs, Hon. Trevor Jones, Associate Minister of Emergency Preparedness and Response, and Hon. Sylvia Jones, Minister of Health, and Good Roads. Carried.

Councillor Plowright pulled Item No. 10 and spoke to the information that was on Page 4 of the Financial Statements regarding the 2017 Agreement, which has now been replaced with the 2023 Agreement. Staff will reach out to Mulmur Township about this.

Items for Council Action

Budget

Discussion ensued on the draft budget which shows a 12% increase in Melancthon's levy. Mayor White advised that he will be voting against the draft budget at the December NVCA meeting. Staff were directed to forward this to Treasury Staff for inclusion in the Township's 2025 draft budget, and further discussion will take place during budget deliberations.

2. Township of Mulmur Resolution regarding Fire Service Delivery Meeting

Discussion ensued on the motion and Staff were directed to respond to the Township of Mulmur that Council feels it is too early to have a conversation about exploring the creation of a North Dufferin Fire Service Area. Further that Council would like to move forward with the recommendations contained in the Plan and see what the outcome of that is before they are willing to participate in any discussions.

General Business

Notice of Intent to Pass By-law

There were no By-laws for this meeting.

New/Other Business/Additions

1. Ontario Provincial Police 2025 Annual Billing Statement Package

Sarah Culshaw, Treasurer spoke to this item of correspondence. She noted that the Township will face a significant increase in Policing next year and the increase will add approximately 4 percent to our levy. The large increases are being felt by municipalities across the Province and is a result of Bill 124 and the cap on wages.

2. Draft Economic Development Strategy and Action Plan

The deadline for comments is October 23, 2024. There is not a lot of information in the Development Strategy and Action Plan pertaining to Melancthon. Council was asked to forward any comments to the CAO/Clerk, and directed that they be forwarded on to the County.

3. New/Other/Addition

<u>Addition – Resignation of Blaise Meunier from the Horning's Mills Community Hall Board</u>

Moved by Plowright, Seconded by Neilson

That Council accept, with regret, the resignation of Blaise Meunier from the Horning's Mills Community Hall Board and thank her for her contributions to the Board. Carried.

4. Unfinished Business

County of Dufferin Multi-Jurisdictional Fire Protection and Prevention Modernization Plan

Staff were directed to take this item off the Agenda and put it back on for the December meeting for further discussion.

<u>Council meetings – Going to one meeting per month – Further Discussion (Mayor White)</u>

Discussion ensued regarding having only one meeting per month and both Deputy Mayor McLean and Councillor Plowright expressed their concerns with only having one meeting per month, and therefore the meetings will remain status quo. There will be further discussion at the December meeting when Staff bring a Report about the 2025 Council meetings.

<u>Tabled Motion from the April 18, 2024 Council Meeting – Dissolving the Horning's' Mills Park Board and the Corbetton Park Bord to Establish a Melancthon Park Board</u>

This item was deferred and Staff will help coordinate a joint meeting.

Delegations

The following Delegations took place during the meeting.

5:15 p.m. - David Germain, Thomson Rogers attended the meeting at the invitation of Council to speak on the Aggregate Approvals Process. Mr. Germain explained that there are two layers of approval, and they are planning, and the Aggregate Resources Act (ARA) and they run in parallel to each other. Under the Planning approval process, the Township Council is the approval authority and under the ARA, the Ministry of Natural Resources and Forestry is the approval authority and he clarified the two processes for Council and explained what the Ministry is looking for when an ARA application if filed, i.e.- hours of operation, tonnage limits, specific controls around noise and dust, managing and monitoring ground water, post guarry rehabilitation process and sequencing of extraction and this is all set out in site plans. He explained the consultation process under the ARA and advised that if a person, or municipality wishes to participate in the process, they must send in an objection letter to the applicant, otherwise they are out of the process. He spoke briefly to an Interim Control By-law and municipalities do have this tool under the Planning Act to freeze the use for a certain period while reviewing policies, but he noted this is only temporary for a year and could possibly be extended to another year. Mr. Germain then answered questions from Council and the public.

6:00 p.m. - Chris Johnston, By-law Enforcement Officer, Johnston Consulting Enforcement Services attended Council to provide updates on By-law Complaints and Enforcement.
