- 6.1 Priorities and Objectives is vision zero possible?

  Board members discussed priorities and objectives. Reducing traffic concerns including the big 4 (seat belts, speeding, distracted driving and driving), as well as preventing serious injuries and deaths are a priority. How Municipalities can help make roads safer including Educating the public. Sharing new ideas and collaboratively working with the OPP.
- How to get Dufferin County to engage with us as a partner to address the concerns of residents.
   It was discussed that member White had forwarded a resolution to the County of Dufferin to assist with costs associated with extra patrolling of County Roads.

  Prioritize getting information out to the public including public meetings, press releases and notices.
- 6.4 Letter to Dufferin County regarding extra patrolling on County Roads (Darren White).The board is hoping for a response from Dufferin County soon.
- 6.5 Concerned residents regarding traffic concerns on River Road (Cheryl Russel)
  A group approached the Township of Mulmur regarding speeding on River Road. It
  may be advantageous to collaborate with other interested citizens from other
  Townships. It was stated that citizens can do online reporting through the OPP
  portal and the OPP can track traffic concerns.
- 6.6 Concerned resident regarding excessive speed on the 4<sup>th</sup> Line (Melancthon). As per above the OPP recommend using the OPP portal, or alternatively contact the OPP with as much specifics as possible.

  The board requested staff to collaborate and decide what should go on the website, and how to make all the websites contain the same information.
- 6.8 Mennonite Community Road Safety discussion
  Al Blundell spoke to the Community discussion that took place at the Township of

  It was stated that a decrease in patrol hours was due to other assigned hours for the officers, but that the overall service has not changed.
