**WHEREAS**, Canadian businesses provide high-quality goods and services that meet the needs of municipal operations and public projects; and

**WHEREAS**, municipalities have the ability and responsibility to influence procurement policies in a manner that reflects the values and interests of their residents; and **WHEREAS**, strengthening domestic purchasing practices will help mitigate the negative effects of foreign tariffs and reinforce economic resilience within Canada;

**NOW THEREFORE BE IT RESOLVED THAT** the Council of the Corporation of the Township of Melancthon hereby commits to adopting a "Buy Canadian" policy wherever feasible and legally permissible, giving preference to Canadian-made goods and services in its procurement processes. Carried.
